#### Statutory Public Meeting under Section 17(15)(d) of the Planning Act

Chair Carr called the Statutory Public Meeting of Council to order and noted that it was being held under Section 17(15)(d) of the *Planning Act*, regarding the proposed Regional Official Plan Amendment, which implements the results of the Integrated Growth Management Strategy and Regional Council's direction to accommodate population and employment growth within Halton's existing Regional Urban Boundary to 2041 and to develop a framework for planning for growth from 2041 to 2051. The proposed amendment has been prepared under Section 26 of the *Planning Act* and advances changes that support planning for growth in Halton and achieving conformity with the Provincial Growth Plan.

The role of Regional Council at this Statutory Public Meeting is to listen to comments and input from members of the public and to ensure that any person attending this meeting has an opportunity to speak. All submissions made at this Statutory Public Meeting will help Regional Council deliberate adoption of the proposed Regional Official Plan Amendment, which will be considered at a future meeting. Chair Carr clarified that Council would not be making any decisions today related to the Regional Official Plan.
